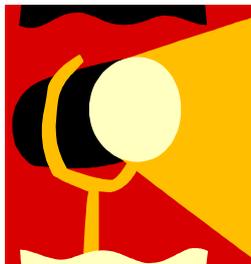

### Evidence-based Decision Making

In part 1 of these lectures, Professor Neal Maskrey describes how our decision making is a key factor in why the quality of the clinical care we provide may vary. “He presents

many amusing and thought provoking illustrations of how cognitive biases affect our everyday decision making, based on over 40 years of research and the work of two Nobel prize winners.”

In part 2 of these lectures, Jonathan Underhill “discusses how we cope with clinical information overload and how we can go about selecting the best evidence to support our decision making. He then helps us think about some possible solutions to help us stay up to date in an efficient manner and how we can perhaps make decisions better by being aware of our cognitive biases.”



### Evidence-informed Public Health




Evidence-Informed Public Health (EIPH) is the process of finding, appraising, distilling

Understanding and interpreting research evidence is an important part of practicing evidence-informed public health. You need to understand some basic concepts. The EU EBM Unity project (funded by Leonardo da Vinci national agency), aims to develop a European Qualification in Evidence Based Medicine (EBM). In the EBM-Basic curriculum you get to know the 5 basic steps of Evidence Based Medicine.

- Module 1. Defining Clinical Question (9 min)
- Module 2. Searching the Evidence (10 min)
- Module 3 and Module 3a on critical appraisal (8 min and 15 min)
- Module 4. Applying evidence to patient (27 min)
- Module 5. Implementation of evidence into practice (12 min)
